Q & A

- Q – Are the documents as per the DOE requirements?
- A – Yes. The system contains all QMS specified documents which are downloadable. Their designs align with the requirements laid out in the Collective Agreement Number 2 of 2020 of the Quality Management System (QMS) for School-Based Educators.
- Q – Which documents are in QM Easy and can they be printed?
- Annexures included: (Please refer to the Collective Agreement 2 OF 2020 document for actual layout formats):
 - A1, A2
 - B1, B2, B3
 - C1, C2, C3
 - D1, D3
 - E1, E2, E3ie: Workplans, Self Appraisals, QMS Appraisals, Lesson Observations, Score Sheets & Summary Score Sheet plus Classroom Reviews (bonus feature)

All documents are downloadable as PDF's and printable. (except the Summary Score Sheet, which a spreadsheet. The DoE needs it like that)
- Q - Is QM Easy changing school QMS?
- A – No and Yes.

No - It is NOT changing the DoE QMS requirements, documentation demands, due dates or Government Schools QMS responsibilities to the DoE.

Yes – It is changing:
The way schools are able to administer the QMS system.
The amount of time required to complete schools QMS responsibilities.
The accuracy of QMS documents, alleviating pressure on all users & the DoE.
The amount of energy and resources required to manage schools QMS.



Q & A

- Q – Are there any other benefits?
- A – We haven't even started to discuss the savings made by reducing the amount of printing, paper, ink, searching & checking time as well as the use of additional resources to compile packs of documents when required. These benefits are over and above the time savings already mentioned.
- Q – Is it mobile device friendly?
- A – Yes, even though it is a website, the screen automatically adjusts to suit a user's device, so appraisals and observations can be done on a phone, tablet or computer, Android, iOS or other, it makes no difference, QM Easy will run on all of them.
- Q – Is QM Easy Secure?
- A – Yes it is a secure <https://> website hosted on a cloud server, hosted by one of the biggest service providers in South Africa. Users' passwords are all encrypted to the point where even our database administrator cannot access them. All relevant recovery procedures are in place should, in the unlikely event, there be a catastrophe.
- Q – And what about training and support?
- A – The platform itself contains comprehensive downloadable training instruments and manuals for users at all levels. Covering all details from profile activation, first use and enrolments, all the way through to how to download the DoE Annual Submission pack by the principal.
